Move forward and negotiation with Tax Commissioner and seek option of bringing taxes in house by:

- Implement a RFP/ RFQ procedure for the option to bring tax collection in house.
- Enter into negotiation to determine final amount if City remains with Tax Commissioner to collect City taxes.
- The Two final numbers referenced-above to be brought before the Commission at the first meeting in March.

City Manager asked the City Attorney to look into the legality of the option of negotiating fees.

City Manager Drumm was instructed to find out the percentage of uncollected taxes.

Commissioner Cason stated staff should submit more detailed information in order for the Commission to make informed decisions.

- City Manager Drumm was instructed to look at including an incentive fee for the collection of taxes.
- 9. Consider Confirmation of the City Manager Appointment of Consuella Caudill to the Position of Assistant City Manager.
