PRESENTATION

1. Presentation by Symbiocity Regarding Highway 17 Corridor Design Project.

Denise Grabowski, Principal and Eric Brown, Principal with Symbioscity reported that they are conducting stakeholder's interviews on today, April 11, 2016 through April 12, 2016 to received input/comments. City Manager Drumm gave a brief synopsis of March 14, 2016 SPLOST VI list. Following discussion the Commission reviewed the list and made revisions to the list bringing the total from 19,450,000 to 15,995,000 and renamed "Park Rehab at Palmetto and Orange Squares" to Rehab of City Parks.

Commissioner Cason made a motion approving the revisions made to the Working SPLOST VI List; seconded by Mayor Pro-Tem Williams. Motion passed unanimously by a vote of 5 to 0.

City Manager Drumm was instructed to retrieve a copy of the County and Brunswick-Glynn Joint Water and Sewer Commission revised SPLOST VI list and provide Commission with a copy of same.

Commissioner Cason made a motion to adjourn; seconded by Commissioner Harris. Motion passed by a vote of 5 to 0.
