Scott Lutes, Chairman, Brunswick Historic Preservation Board, gave a report on the background of the above-referenced appeal and explained why the board denied Mr. McDonough's Certificate of Appropriateness to demolish structure located at 1315 Union Street.

Chris Amos, consultant for Joe McDonough addressed the Commission in regards to Mr. McDonough's plans to demolish the structure located at 1315 Union Street.

Joe McDonough, owner, addressed the Commission regarding he reasons for wanting to demolish the structure located at 1315 Union Street.

Hill) Commissioner Harris made a motion to allocate \$5,000.00 to the Urban Redevelopment Agency for training; with City Manager approving training request(s) as request for same is submitted; seconded by Mayor Pro-Tem Williams. Motion passed unanimously by a vote of 5 to 0.

Assistant City Attorney Corry reported on the State law and City ordinance for Sunday Sales for the above-referenced organization; he stated absent documentation demonstrating that an organization derives more than fifty percent of its gross sales from food or fifty percent of its annual income from the rental of rooms, an organization is not eligible to sell alcohol for on premise consumption on Sundays in accordance with the ordinance.
