The 2021 Annual Plan specifies available resources to meet the identified needs. The financial resources the City projects an entitlement grant of \$383,470 of Community Development Block Grant funds during the program year which will run July 1, 2021 through June 30, 2022.

It is expected that City Commission will approve the annual plan on April 21, 2021 during the regular meeting beginning at 6:00 p.m. at Old City Hall, 2nd Floor. Box 550, Brunswick, Georgia 31521. All comments received by April 19, 2021 will be considered.
