#### RATIONALE FOR AMENDMENT

"The Coronavirus Aid, Relief, and Economic Security Act," CARES Act which was signed into law on March 27, 2020, provides funds through the CDBG, ESG and HOPWA programs. The CARES Act provides for allocations of funds to prevent, prepare for, and respond to coronavirus.

The **City of Brunswick** has taken stock of local needs and the parameters of each of the programs and determined how the funds allocated will be used in this community. The following activities will be funded:

- 2. Testing or Assessment Site for LMI Residents Coastal Community Health Services
- 3. Mobile Sanitizing Stations City of Brunswick
- 4. Cleaning Supplies Packages & PPE United Way
- 5. Emergency Shelter Extensions for Homeless -The Salvation Army
- 6. Extension of Homeless Services The Well Day Shelter
- 7. Hotel/Motel assistance Safe Harbor
- 8. Food Assistance Second Harvest Food Bank
- 9. Food Assistance Lady K's (MWE business, Food Delivery for LMI Children)

## PR-15 Summary of the citizen participation process

The U.S. Department of Housing and Urban Development (HUD) granted several waivers to program procedure to expedite the use of these funds. These waivers included an ability to amend the Citizen Participation Plan and allow for a much shorter timeframe for public display, use of the internet to make the Substantial Amendment available to the public and use of virtual meetings to allow for input and comment. The City of Brunswick advertised and made the Substantial Amendment available to the public on April 30, 2020 for a period of five days and held a virtual public hearing via ZOOM on May 13, 2020 at 10AM. ## **Project Summary Information**

The funds are being dispersed on three main areas of Brunswick LMI population; shelter, food and health. We have put together an experienced group of non-profits that are well established in the community. These non-profits will target the specific short-term needs of Brunswick's LMI population.

Through Second Harvest Food Bank and Lady K's, we are allocating \$16,108 for food assistance for our LMI population. Coastal Community Health Services and United Way will provide sanitation stations, cleaning supplies and testing sites. Their allocation is for \$80,000 and it will help our LMI population with the proper tools to stay healthy and avoid further spread of the COVID-19.

Our homeless population needs our help more than ever now. They are part of the most vulnerable group because of the lack of shelter. We have allocated \$85,000 for the purpose of providing hotel/motel and other housing services. The Salvation Army, The Well Day Shelter and Safe Harbor are providing these services.

We believe that these allocations will provide the safest and fastest way to fulfill the needs of Brunswick's LMI population. The administrative allocations are for \$45,276.00.
