Progress the jurisdiction has made in carrying out its strategic plan and its action plan. 91.520(a)

The Housing and Development Community Development Act of 1974, as amended, requires all Community Development (CDBG) and HOME entitlement programs to prepare and submit a Consolidated Annual Performance and Evaluation Report (CAPER) to the U.S. Department of Housing and Urban Development (HUD) at the close of each program year. The City of Brunswick is an entitlement community for this program as designated by the U.S. Department of Housing and Urban Development and receives annual allocation of (CDBG). The CAPER provides the City of Brunswick and interested stakeholders the opportunity to evaluate the progress in carrying out priorities and objectives contained in the City's five-year plan.

This is the second report for the five-year period beginning July 1, 2020. A new Five-Year plan was developed for the period beginning July 1, 2020, to run through June 30, 2025.

For FY 2021 (July 1, 2021, to June 30, 2022), the City of Brunswick undertook a variety of activities funded by CDBG in the City in the areas of:

- Public Services to low- to moderate-income persons and families by funding three (3) human services agencies in the city. The CARES Act provided the City with additional resources through which four (4) agencies were funded to provide services to persons impacted by Covid including persons experiencing homelessness.
- Affordable Housing Provide Housing Rehabilitation to improve the condition of low/moderate-income owner-occupied homes. Rehabilitation of six (6) homes was anticipated. The City completed 13 (thirteen) rehabilitation projects in 2021. In addition, Rebuilding Together of Glynn County was funded to install handicap ramps for 2 people with disabilities.
- Public Facility improvement The old roof at the Roosevelt Harris, Jr. Senior Citizen Center was failing and causing interior damage to two buildings. The deteriorating ceiling was becoming a human hazard. Roof replacement on two buildings and the breezeway connecting the buildings (10,000 square feet) was completed within budget and dateline during FY' 21.
- Sidewalk improvements During FY'19 the Midtown Sidewalk Improvement Project was bid on and awarded. The pre-construction conference was held, and the contractor started work in November. The project was completed in the Spring 2020. The final payment was made in July 2021.
- Slum/Blight Removal-The City demolished six blighted properties in an effort to improve neighborhood conditions and prevent further deterioration in residential neighborhoods.

The progress described in this report illustrates the City's efforts to utilize CDBG funding and enhance coordination with Community Development programs to create a more vibrant and livable community and improve the quality of life for low-income citizens in the City of Brunswick.

While still navigating the challenges of the COVID-19 pandemic, the City was able to make significant progress on many activities in FY 2021. Our team continued to prioritize the needs of the community without neglecting the City's Strategic Plan goals and objectives.

CDBG CV funds in the amount of \$374,525 were provided to the City in two tranches. These funds were used to provide funding as follows:

- 1. Program Administration City of Brunswick
- 2. School Sanitizing Stations City of Brunswick
- 3. United Way of Coastal Georgia Cleaning Supplies and PPE
- 4. Hotel/Motel assistance Safe Harbor
- 5. America's Second Harvest of Coastal Georgia
- 6. FaithWorks Ministries Supply food to homeless individuals

During 2021, the City expended \$5,000 for Hotel/Motel assistance for individuals or households needing to quarantine; \$20,000 for PPE and cleaning supplies for the United Way of Coastal Georgia; \$22,500 for the Second Harvest food pantry; \$9,200 for FaithWorks Ministries. The City also prepared a substantial amendment for CDBG-CV funds to provide assistance to the Roosevelt Senior Center to expand their outdoor gathering space in an effort to provide sufficient social distancing space for seniors.

Assess how the jurisdiction's use of funds, particularly CDBG, addresses the priorities and specific objectives identified in the plan, giving special attention to the highest priority activities identified.

All the City's funding sources address the priorities and specific objectives identified in the Consolidated Plan. All funded activities meet at least one of the highest priority needs identified in the Consolidated Plan.

Investments were allocated according to responses to programmatic opportunities and client response to funding availability. Rehab programs were targeted to the CDBG eligible areas or as individual benefit to low-income households. Public services were offered to persons residing in low-income areas and to all qualified residents.

The City continues to make available a significant portion of the federal grants to programs and activities that directly benefit low–income residents. Health and human services initiatives help individuals and families achieve self-sufficiency and thereby break the cycle of poverty. These services include nutrition, education, after school and GED instruction and homelessness services. With regard to non-housing issues, the

City was fortunate to benefit from its partnership with nonprofit organizations that provide direct services to families for basic human needs. These organizations could assist hundreds of low-income individuals by leveraging CDBG funding with other funding sources.

In FY 2021 the City funded activities for housing rehabilitation and human services. The City spent 89% of its CDBG funds on activities benefiting low-income individuals and families. The City also utilized funds to demolish blighted properties. Six demolitions were completed in 2021.

The community works well together to serve low-income persons. Organizations and entities not funded with CDBG continue to partner with the City's CDBG Program to assist in serving residents of Brunswick and achieving the goals of the Consolidated Plan. The Housing Authority (PHA), Habitat for Humanity of Glynn County Georgia, Rebuild Together, Goodwill Southeast Georgia, the United Way, Glynn Community Crisis Center, Grace House, Star Foundation, Coastal Georgia Area Community Action Authority and Communities in Schools along with other nonprofit organizations support the City's goals outlined in the Annual Plan. In addition to the City's investment of CDBG funds for housing rehabilitation for low- and moderate-income persons, the Brunswick Housing Authority, Salvation Army, and Faith Works serve the transition and affordable housing needs of low, low-moderate, and very low-income persons through public and assisted housing programs. The Safe Harbor Children's Center Youth Homelessness program, helping the City assist its youth runaway and homeless population. Along with the agencies that assist in the provision of affordable housing, Amity House and Faith Love serve victims of domestic violence and sex trafficking.

Additional attention to high priorities

The City of Brunswick fosters the growth and vitality of the local economy through attraction, retention and expansion of quality businesses and industries, both large and small, as noted in the 2020-2024 Consolidated Plan. The City facilitates re-development using a citizen-centered approach that ensures integrity, innovation, and responsiveness. Through a comprehensive strategy, the City seeks to create positive change by promoting self-sufficiency through partnership in economic development, quality housing, and neighborhood reinvestment. The City did not utilize 2021 CDBG funds for this purpose.

Narrative

The City's housing rehabilitation program provided assistance to 15 housing units in 2021 (14 African Americans or Blacks)

The City requires sub-grantees/sub recipients/public agencies to collect race and ethnicity information using nine different categories in addition to Hispanic ethnicity. The figures above do not consider the "other" multi-racial categories which included 6 people. Services funded by CDBG are provided to low-moderate residents in the City in the following areas:

- Youth Services Provide low to moderate children at eighty (80%) or below the median income
 with a structured educational after school and summer camp program. Servicing: 109 low to
 moderate income residents primarily from Brunswick Housing Authority complexes.
- 72 individuals were served through Coastal Outreach Academies

Of those served in 2021, (seventy-two) 72% percent were Black or African American. The population of Brunswick was 33.8% White and 61.1% African American, according to the 2020 U.S. Census. The total number of households in Brunswick is 6,169. Of the 6,169; 2,202 (35.7%) live below the HUD 80% AMI limit. Census data shows that Black or African American residents of Brunswick have a disproportionately greater need and experience higher unemployment and lower incomes. African Americans reside mostly in the western parts of Brunswick (CDBG eligible area). Those tracts range from 62 to 76 percent of the total population of the city.

Narrative

Many of the activities undertaken in 2021 were public services which served low-income households regardless of location. Coastal Outreach Academies served 72 students from low-income areas in Brunswick.

Maps show some census tracts in western parts of Brunswick are home to relatively high portion of the city's African American population, with the total African American population in those tracts ranging from 62 to 76 percent of the total population of those tracts, in a city where the total African American population is 61 percent of the total population of the city. Likewise, there are tracts in the eastern parts of the city that are home to relatively high portion of the city's Hispanic population, ranging from 10 to 27 percent of the total population of the tracts, compared to a total Hispanic population in the city of about 9 percent.

Discuss the difference between goals and outcomes and problems encountered in meeting these goals.

The City met the Affordable Housing Objective by rehabilitating 13 housing units and providing funds to Rebuilding Together to undertake construction of handicap ramps for persons with disabilities. They created 2 ramps. The Georgia Department of Community Affairs (DCA) used the Homeowner Rehabilitation and Reconstruction Program (HRRP) to meet housing needs as well.

Discuss how these outcomes will impact future annual action plans.

Covid has skewed the results of what can be accomplished with CDBG. Much energy and time was poured into the CDBG CV allocation process and ensuring that the needs of City residents who were

most seriously impacted by Covid received the services that they needed. In 2021, however, the City was able to get mostly back on track and made significant progress on its 2020 and 2021 goals.

The City of Brunswick is not a HOME Program recipient. Income intake is conducted for the youth public service recreation and after-school and summer camp activities.

homelessness through:

Reaching out to homeless persons (especially unsheltered people) and assessing their individual needs

There is a street outreach team through Safe Harbor which canvasses the community every day. There are two canvassing teams. There are hotel/motel vouchers for families experiencing homelessness. There is a women's STIVE program that has the goal of transitioning women into apartments; the group home for women is full.

COVID-19 has had an impact on the work done reaching out to persons experiencing homelessness. There is currently limited contact with individuals and staff are doing assessment by phone and social media. The only community event was related to voting. There was an explosion in need for the hotel/motel voucher program; it has nearly doubled in need. Even with restrictions in place for street outreach, the outreach and Coordinated Entry programs have almost doubled. Stakeholders also report an increase in evictions.

The City funded several public service activities geared towards outreach to the homeless, particularly homeless youth. Through the provision of youth activity programs, the city assisted 135 homeless persons.

Addressing the emergency shelter and transitional housing needs of homeless persons

The following is a list of some of the activities being done to address the emergency and transitional housing needs of individuals:

- Saved by Grace was added to referral system, particularly for single men.
- Salvation Army's program continued.
- Zach's Place for birth to age 17 has continued.
- STRIVE program for age 16-22 has received HUD rapid re-housing funds.
- Gateway program has provided funding for emergency shelter due to COVID.

Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: likely to become homeless after being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); and, receiving assistance from public or private agencies that address housing, health, social services, employment, education, or youth needs

Safe Harbor was awarded \$10,000 in CDBG to decrease and prevent homelessness in PY 21. In the Annual Plan it was estimated that 50 youth would be served through the Safe Harbor Children's Center. 121 people were served by the Safe Harbor Children's Center.

Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again

No funding was provided to address issues relating to transitional housing for the homeless. The City supports the efforts of the Continuum of Care to address homelessness issues through their funded organizations.

Actions taken to address the needs of public housing

The City is currently does not allocate any CDBG funds to Brunswick Housing Authority, the City continues to encourage Brunswick Housing Authority to make capital improvements and continue with programs to increase the quality of life of Public Housing tenants.

Actions taken to encourage public housing residents to become more involved in management and participate in homeownership

Residents are involved with management and operations of the public housing developments through participation on resident councils. Brunswick Housing Authority looks for opportunities to hire residents for contract work through its Section 3 obligations.

Actions taken to provide assistance to troubled PHAs

The Brunswick PHA is not a troubled agency.

The Five-Year plan did not identify any barriers within public policy that serve to limit housing choice and development.

Actions taken to address obstacles to meeting underserved needs. 91.220(k); 91.320(j)

The City continues to research new funding sources and partners for programs to address underserved needs. Organizations such as Family Connections, United Way, Safe Harbor Crisis Center, and the Salvation Army provide aid to families in need through monthly meetings, health fairs, resource fairs and other avenues. The greatest obstacle to providing the resources needed to break the cycle of poverty is limitations in funding.

Actions taken to reduce lead-based paint hazards. 91.220(k); 91.320(j)

All homes proposed for rehabilitation are inspected for lead-based paint hazards by a third party. Posters warning of the dangers of lead-based paint are posted in the Economic and Community Development Department office and other locations in City Hall. Information is provided to contractors by the Permits Office about their responsibility to inform customers about lead-based paint.

Actions taken to reduce the number of poverty-level families. 91.220(k); 91.320(j)

The City partnered with Family Connections, Coastal Georgia Community Action Authority, Coastal Coalition for Children, Ameri Group, COC, Coastal Work source, Georgia Department of Labor to reduce the number of poverty-level families through the development of programs and services needed to assist those families with education, job opportunities and life skills training.

Actions taken to develop institutional structure. 91.220(k); 91.320(j)

The City funded and continues to work with nonprofit organizations to address community needs and to provide supportive services. Private partnerships were sought to address housing needs and to leverage funds.

Actions taken to enhance coordination between public and private housing and social service agencies. 91.220(k); 91.320(j)

The City remains committed to coordinating planning activities with private housing and social service agencies, including the COC. The city staff also continued its participation in other coalitions and study groups, when invited.

Identify actions taken to overcome the effects of any impediments identified in the jurisdictions analysis of impediments to fair housing choice. 91.520(a)

During FY 2019 the City completed work on an updated Analysis of Impediments. The City engaged the firm of Mullin and Lonergan Associates, Inc. The AI was adopted by the City in February 2019. The City had planned to undertake Fair Housing educational programming in 2020 but was sidetracked by COVID. The impediments identified in the AI will be addressed by the following actions:

- Modify existing zoning ordinances to allow multi-family units in more districts throughout the city and develop an inclusive definition of family to allow for group homes to meet the definition of family.
- o Revised zoning ordinance with regard to definition of family
- o Revised zoning ordinance to allow multifamily units in more residential districts

No action taken in 2021

- Expand housing choice and access to opportunities by increasing the locations and types
 of affordable housing including for persons with disabilities.
- o Create an Affordable Housing Overlay with particular attention to census tracts included in the federally designated Opportunity Zone to preserve existing affordable housing and to encourage private investment in underserved neighborhoods.
- o Encourage Brunswick Housing Authority to include disability status in preferences

- Increase the level of fair housing knowledge and understanding among housing developers, real estate professionals, elected officials, landlords, lenders potential homebuyers and the general public
- Within six months, create a page in a prominent location on the City's website for fair housing resources

The City of Brunswick Department of Economic and Community Development monitors CDBG activities a minimum of once per year. A monitoring report form is used to detail information regarding the number of files reviewed, the number of files in compliance, if any procured materials were identified and properly procured, along with a summary of conclusions and findings, if any. The City's Finance director, Neighborhood Revitalization Manager and Grant Administration also monitor the financial records, to ensure the subrecipient complies with all CDBG accounting and financial regulations. The accountant has a separate financial monitoring system to use as an evaluation tool.

Every year CDBG reviews all files, records, budgets, board information, and overall compliance in the use of CDBG funds. We inform the subrecipient in advance of all items City will review on the agreed monitoring date. The city has scheduled site visits which allow the Program Specialist to sit in during engaged services and view the impact of services provided to residents.

Outreach included a public forum for the general public and a focus group meeting and consultation with public and private agencies and organizations to capture public input. Public and private consultation included elected and appointed government officials, neighborhood organizations, public and social service agencies, colleges, and universities, and the Economic and Community Development Advisory Group.
