RESOLUTION No. 2021-04

A RESOLUTION OF THE CITY OF BRUNSWICK, GEORGIA TO CLARIFY ITS PREVIOUS MOTION CONCERNING THE FUTURE OF THE CONFEDERATE MONUMENT IN HANOVER SQUARE

WHEREAS, on November 18, 2020, at a Regularly Scheduled Meeting of the Commission of the City of Brunswick, Georgia, the Commission passed the motion ("Motion") made by Commissioner Williams concerning the Confederate Monument ("Monument") in Hanover Square.

WHEREAS, the Motion stated the City's intent to remove the Monument, contingent upon outcomes in pending litigation concerning cities and counties in Georgia. The City also reserved the right to modify or amend the motion based upon the outcome of the pending legal actions. The Motion demonstrated the City's intention to, above all else, comply with applicable law.

WHEREAS, the Commission of the City of Brunswick now desires to clarify that Motion, specifically with regard to identification of the pending litigation referenced therein.

NOW, THEREFORE, LET IT BE RESOLVED BY THE COMMISSION OF THE CITY OF BRUNSWICK that there has not been a determination that the City of Brunswick owns the Confederate Monument in Hanover Square,

BE IT FURTHER RESOLVED that the City will delay the intended removal of the Confederate Monument from Hanover Square until the Georgia Court of Appeals issues opinions in the following cases:

SONS OF CONFEDERATE VETERANS et al. v. NEWTON COUNTY BOARD OF COMMISSIONERS, Georgia Court of Appeals Case No. A21A0734, and

SONS OF CONFEDERATE VETERANS, MAJOR GENERAL JOSEPH WHEELER CAMP NO. 863 v. OZ NESBITT, SR. et al. A21A0794.

BE IT FURTHER RESOLVED that the City will remove the Confederate Monument from Hanover Square if the Court of Appeals' opinions in the above-identified cases illustrate that such removal is supported by applicable law.

BE IT FURTHER RESOLVED that while the above-identified cases are pending, the City of Brunswick reserves the right to accept the Confederate Monument Advisory Committee's recommendation to place a plaque or marker near the monument that shall provide historical contextualization explaining the prevailing ideologies of the time period in which it was erected.

BE IT FURTHER RESOLVED, the City reserves the right to modify or amend this resolution based on the outcomes of the above-identified cases.
