## RESOLUTION OF THE COMMISSION OF THE CITY OF BRUNSWICK APPROVING THE 2021 ANNUAL ACTION PLAN FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM

WHEREAS, under Title I of the Housing and Community Development Act of 1974, as amended, the Secretary of the U.S. Department of Housing and Urban Development is authorized to extend financial assistance to communities in the elimination or prevention of slums or urban blight, or activities which will benefit low- and moderate-income persons or other urgent community development needs; and

WHEREAS, the U.S. Department of Housing and Urban Development has identified the City of Brunswick (hereinafter "the City") as an entitlement grantee; and

**WHEREAS**, the City will receive an entitlement allocation through the CDBG Program for FY 2021 of \$383,470; and

WHEREAS, the City has prepared an Annual Action Plan for FY 2021 to outline the proposed use of the CDBG funds; and

WHEREAS, the City held a public hearing to identify needs within the city on February 10, 2021; and the City has made the Annual Action Plan available for citizen review and comment for a period of thirty (30) days consistent with its Citizen Participation Plan and considered comments received; and the City held a second public hearing to solicit comments on the Annual Action Plan for FY 2021 on April 6, 2021; and

**WHEREAS,** the City is required to submit the Annual Action Plan to the U.S. Department of Housing and Urban Development by May 14, 2021;

## NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF BRUNSWICK:

- 1. That the Community Development Block Grant Annual Action Plan for FY 2021 is hereby in all respects approved and the Clerk is hereby directed to file a copy of said Annual Action Plan with minutes of this meeting.
- 2. That it is cognizant of the conditions that are imposed in the undertaking and carrying out of community development activities with federal financial assistance, including those relating to (a) the relocation of site occupants and, (b) the prohibition of discrimination because of race, color, age, religion, sex, disability, familial status, or national origin, and other assurances as set forth under the certifications.
- 3. That the Annual Action Plan for FY 2021 be submitted to the U.S. Department of Housing and Urban Development Atlanta State Office for their review and approval.

- 4. That the Mayor, on behalf of the City Commission, is hereby authorized to provide such assurances and/or certifications as required by the Housing and Community Development Act of 1974, as Amended, the National Affordable Housing Act of 1990, and the Stewart B. McKinney Homeless Assistance Act of 1988, as amended, and also any supplemental or revised data which HUD may request in connection with the review of this Application.
- 5. That the Mayor is authorized to execute on behalf of the City the formal grant contracts, amendments, and other documents relating to the City's FY 2021 CDBG Annual Action Plan.
